

## **Faculty and List B applications.**

### 1. Faculty application for

- the installation of pew heaters including floorworks and electrical wiring, and new control panel to enable the installation of the heaters to the pews
- the purchase and use of heated pads for those pews without heaters
- the removal of the existing gas boiler, pipework and radiators for the existing heating system
- removal of the two redundant fan convection radiators at the western end of the nave
- installation of infra-red heaters in apse, nave and adjacent to electric piano and organ
- where necessary, plaster patching.

2. .Faculty application for a shed for the new Men and Woman Shed for the Nuneaton branch of this organisation, involving the extension of the existing concrete base at the rear of the main hall in the community centre, the construction of a wheelchair-accessible ramp linking the centre to the compound, the erection of a timber shed measuring approximately 10ft by 22ft, and the relocation of the existing metal sheds currently used by community centre members, together with the installation of a safe electrical supply and lighting.

3. List B application for stripping back plaster 100m either side of crack (southeast wall) to enable assessment of what action should be taken.

4. List B application for replacement of light fittings to LED lights.

5. List B (or faculty) application for root barrier and installation of water irrigation system to south of Sycamore tree located close to the southeast corner of the Church.

*Actions needed before submission-. Amendment to Statements of Significance and Need, if needed.*

6. List B (or faculty) application for installation of new audio and visual equipment including large TV screens on coves in east walls and central position of north and south walls. Internet Access & Smart Heating Control Infrastructure.

*Submission Target- January 2026.*

*Actions needed before submission- amendment of Statements of Need and Significance.*

7. List A or B application for disposal of surplus furniture, piano, equipment, kneelers, redundant worship books.

*Submission Target- February 2026.*

*Actions needed before submission- PCC authorisation for disposal of items, amendment of Statements of Need and Significance, Specifications and plan for new equipment and screens.*

8. Faculty application for the installation of 24 panel, 10.68kWpk solar PV system on the main hall roof in the community centre with 2 x 9.32kWh Fox battery systems.

*Submission Target- March 2026.*

9. Faculty application for installation of wheelchair ramps to west door and to the planned reopening of south door. Installation of lighting adjacent to south door for safe access/egress during dark hours.

*Submission Target- March 2026.*

*Actions needed before submission- appointment of someone to design them.*

*Amendment of Statements of Need and Significance. Further PCC resolution for ramp to south door.*

10. Faculty application for the repair of the leaded windows and hoppers on the south side of the Church and hoppers only to the leaded windows on the north side.

*Submission Target- February 2026.*

*Actions needed before submission- PCC authorisation and amendment of Statements of Significance and Need.*

11. Faculty application for all the repair items set out in the Quinquennial Report 2023 with the addition of upgrading the roof-drainage system to accommodate higher rainfall intensities anticipated as a result of climate change, including the installation of four 1000 litre rainwater-harvesting butts on the north side. The installation of snowguards

*Actions needed before submission. PCC authorisation and amendment of Statements of Significance and Need.*

12 Faculty application for the removal of the remaining section of the stone cross at the east end of roof and its replacement with a contemporary cross fabricated in a more economical material, with the option for discreet illumination.

*Submission Target- February 2026*

*Actions needed before submission- Calculations of water discharge from roof to help with specification of any new guttering and downpipes, Specification and drawing of new cross on eastern end, PCC authorisation and amendment of Statements of Significance and Need.*

13 Faculty application for two new rooms under existing balcony and alterations to existing internal porch, repair of plaster. Additionally, to accommodate the new rooms, the font to be repositioned approximately 3 metres to the east of its current location. Fit external coded lock and closers adjacent to south door.

*Submission Target- March 2026*

*Actions needed before submission- Appointment of architect to design new rooms, PCC resolution, Amendment of Statements of Significance and Need.*

14 List B or Faculty application for redecoration of interior of church.

*Actions needed before submission- Specification for decoration works, Justification if not following Conservation Officer's advice.*

*Submission Target- March 2026*

*Actions needed before submission- Appointment of architect to design new rooms, PCC resolution and if needed amendment of Statements of Significance and Need.*

15 Faculty Applications for installation of new carpets in aisles and under existing pews.

*Submission Target- March 2026*

*Actions needed before submission- Specification details of type and colour of new carpets, PCC resolution and if needed amendment of Statements of Significance and Need.*

Further faculties and minor works applications may be needed in relation to

- community garden especially for any proposed memorial garden and any removal and re-siting of remaining headstones currently located within the original graveyard, placing them in an agreed alternative position.
- establishment of heritage facilities within the Church.
- repair of spiral staircase to balcony, permanent access to Bell Tower and Roof Space to current safety standards, illuminated cross in bell tower, external lighting to highlight western elevation, Storage facilities on balcony, new locked door to balcony to prevent unauthorised use especially when south door is reopened.

**Other permissions and consents needed.**

Planning Applications for extension of concrete base behind hall to accommodate a Men and Women Shed and any existing sheds. New Shed and ramp.

Planning Application for solar panels on community centre hall roof.
